



Dear Citizens,

**SUBJECT: Start of the new urban solid waste collection system - EXTERNAL/RED AREA (SUBURBS Rorai Cappuccini and Viale Venezia North) OF PORDENONE.**

Waste management represents one of the most important challenges in terms of environmental protection, sustainable development and health protection. The Municipality of Pordenone and its partner GEA Company are committed to a constant improvement of environmental *standards* to ensure a safe and sustainable present and future for our citizens. However, the current system of urban solid waste collection, public street trash containers, has outlived its usefulness because it does not allow the control and measurement of waste disposal and encourages the abandonment.

The last few years have been characterized by a deterioration in the quality of recycled waste collection and increased costs that arise from recovery/disposal and management of treatment plants.

For these reasons, it has been decided to change the current recycling system by intervening on collection methods and service frequencies. Waste taxation criteria will begin on 1 January 2023.

**The following major changes will be implemented in your collection area from 09 November 2022:**

- 1) All public street dumpsters used to collect paper/cardboard, plastic/aluminum/food cans packaging, garden waste and clippings will be removed;**
- 2) Each user/family will receive dedicated and individual trash container for door-to-door refuse separation collection.**

Trash containers have been chosen in such a way as to cause the least possible inconvenience to the users. Although these new trash containers, called "Easy Trolley", have a reduced volume (45 liters), they are wheeled and ergonomics and will be used specifically for the collection of paper/cardboard and non-recyclable dry waste. Additionally, users will receive 100 liters disposable bags for the collection of plastic, food/soda cans, aluminum and packaging.

New information that will affect your family/activity from **09 NOVEMBER 2022** are explained in the following pages that we invite you to read with particular attention. The new collection system will begin on 1 January 2023, it is preparatory to the application of fees calculated on the basis of actual waste collection amounts (fee-based pricing). The TARI (waste tax) remains active throughout 2022. The current waste tax is calculated on flat-rate criteria such as the surface area occupied and the estimated count data based on the household waste generated.

From 1 January 2023, the TARI will be replaced by the *corresponding rate* (Law n.147/2013 art. 1, paragraph 668), which requires users to pay a proportional amount to the service used and it will be calculated on the disposal of non-recyclable dry waste. We remind you that the new urban solid waste collection system and use of the new trash kit for waste collection is mandatory. The various phases that will precede the start of the new waste collection system, in particular the distribution of the containers and the informational material, will require the collaboration and participation of all citizens.

The days of door-to-door collection service and the times for placing the containers out of your residence will be listed in the CALENDAR that will be distributed with the trash- kit.

PLEASE NOTE: there may be changes from the current waste collection days.



## TRASH KIT PICKUP PROCEDURES

To speed up the delivery of new containers and in order to pick up the trash kit, it is important that the American citizens show up with the **copy of the rent contract (copy of the first page only)**.

**NOTICE: Users, in order to pick up the new trash container, must show up at the GEA Info Point bringing with them the Yellow Non-recyclable dry waste container "NAPO," that must be returned to GEA.**

Trash kit pick up should preferably be made by the landlord/landlady (person named on the TARI waste bill) or by another member of the family. If the landlord/landlady are not available to pick up the trash kit, they should delegate the tenants -filled and signed the attached form-, providing also a copy of delegation signed by the landlord/landlady and a copy of the delegating person's ID.

**Users can pickup the "standard trash kit" at the Info Point GEA located in Via Savio, 22 - Pordenone. Trash kit pickup should be arranged by making an appointment following these specific instructions:**

**IMPORTANT NOTICE:**

- Trash containers are provided on loan for free use and must be returned upon termination of service.
- Annual fees **are inclusive of COLLECTIONS**;
- Garden Waste and Clippings collection service will be performed with the following frequencies:
  - DECEMBER - JANUARY = MONTHLY frequency;
  - FEBRUARY - NOVEMBER = EVERY TWO WEEKS frequency;
  - MARCH to OCTOBER = WEEKLY frequency.
- 🕒 Garden Waste and Clippings must be disposed of UNPACKED (without plastic bag);
- 🕒 No waste will be collected outside the container provided: for larger quantities, the supplementary service must be activated;
- 🕒 FREE OF CHARGE disposal to the Municipal Waste Collection Center is always allowed.
- 🕒 The service is considered automatically renewed until a formal cancellation will be communicated at the email address [sportellopn@gea-pn.it](mailto:sportellopn@gea-pn.it)
